Bids must be accompanied by a Bid Security in the amount as mentioned in the above table either in the form of Bank Voucher in the name of **Rastriya Banijya Bank Mugum Karmarong Branch Sanchit Account No. 45500304010003** or irrevocable and unconditional Bank Guarantee issued by "A" class commercial bank with a minimum amount as indicated in the above table. The bid security shall be valid for 30 days beyond the validity period of the bid.

4.0 Eligible bidder can obtain Standard Bid Document (SBD) within **2077-06-14 (30 september, 2020) at (office hour) from office of Mugum Karmarong Rural Municipality.**

5. Bids must be submitted to the office of **Mugum Karmarong Rural Municipality, Mugu**, on or before **12:00 hours (noon) on : 2077-06-15 (1st october, 2020).**

6.0 Bids will be opened at **14:00 pm : 2077-06-15 (1st october, 2020)** in the presence of bidders or their authorized representatives who wish to attend at office of **Mugum Karmarong Rural Municipality, Office of The Rural Municipal Executive, Pulu, Mugu**. Absence of bidder's representative in bid opening shall not obstruct the bid opening.

7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the

sameas specified for the original last date of bid submission.

8. The Bidder must quote unit rates in figure and words for all items of the works described in the Bill of Quantities and shall enter corresponding Amount for each item. Bidder must produce total Bid price and enter in the BOQ as well as in Letter of bid.

9. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever. Any intimidation, collusion and cartelling during bidding process shall be punishable by law.
